

LIABILITY COVERAGE - WAIVER FORM

Members who obtain liability coverage through the League of Minnesota Cities Insurance Trust (LMCIT) must complete and return this form to LMCIT before the member's effective date of coverage. Return completed form to your underwriter or email to pstech@lmc.org.

The decision to waive or not waive the statutory tort limits must be made annually by the member's governing body, in consultation with its attorney if necessary.

Members who obtain liability coverage from LMCIT must decide whether to waive the statutory tort liability limits to the extent of the coverage purchased. The decision has the following effects:

- If the member does not waive the statutory tort limits, an individual claimant could recover no more than \$500,000 on any claim to which the statutory tort limits apply. The total all claimants could recover for a single occurrence to which the statutory tort limits apply would be limited to \$1,500,000. These statutory tort limits would apply regardless of whether the member purchases the optional LMCIT excess liability coverage.
- If the member waives the statutory tort limits and does not purchase excess liability coverage, a single claimant could recover up to \$2,000,000 for a single occurrence (under the waive option, the tort cap liability limits are only waived to the extent of the member's liability coverage limits, and the LMCIT per occurrence limit is \$2,000,000). The total all claimants could recover for a single occurrence to which the statutory tort limits apply would also be limited to \$2,000,000, regardless of the number of claimants.
- If the member waives the statutory tort limits and purchases excess liability coverage, a single claimant could potentially recover an amount up to the limit of the coverage purchased. The total all claimants could recover for a single occurrence to which the statutory tort limits apply would also be limited to the amount of coverage purchased, regardless of the number of claimants.

As requested, we have solicited quotes for street improvements for various streets throughout the City. The proposed work includes full depth patching, mill and overlay patching, and trail paving along Minnetonka Boulevard to improve drainage. The following is a summary of the quotes:

Allied Blacktop \$48,156.00 Midwest Asphalt \$54,695.00

In addition to the quotes for street improvements, we have received a quote through Midwest Asphalt in the amount of \$5,900 for removing and replacing curb and gutter on Excelsior Blvd. to improve drainage.

We have reviewed the quotes and recommend awarding the street improvements to Allied Blacktop in the amount of \$48,156. In addition, we recommend authorizing a cost not to exceed \$5,900 to complete the concrete work on Excelsior Blvd.

Agenda Item: Ordinance 290 revisions to section 600.35, Subd. 3 regarding park dedication.

Summary: The current subdivision code states that park dedication fee may require that the subdivider contribute a cash amount equal to 8% of the assessor's land valuation for the entire parcel prior to subdivision on January 2 of the year of the final plat application. Staff was unclear about the language since park dedication on developed land is typically charged only for new parcels created. The city attorney referenced state statue noting that previously subdivided property from which a park dedication has been received, being resubdivided with the same number of lots, is exempt from park dedication requirements. Also, if as a result of resubdividing the property from which a park dedication has been received, the number of lots is increased, then the park dedication or per-lot cash fee must apply only to the net increase of lots. The city attorney also noted that the value of the land being subdivided, for purposes of calculating the fee in lieu, must be set based on the pre-subdivision value. The attached ordinance amendment is meant to make the requirements align more clearly with state statue.

- 07-11-19 If the 2nd reading is waived, the ordinance is submitted to the Sun-Sailor for publication.
- 07-18-19 If the 2nd reading is waived, the ordinance is published in the Sun-Sailor (goes into effect on this date).
- 08-07-19 City council considers 2nd reading of the ordinance (may make revisions).
- 08-08-19 The ordinance is submitted to the Sun-Sailor for publication.
- 08-15-19 The ordinance is published in the Sun-Sailor (goes into effect on this date).

Council Action: Potential motions ...

I move the city council (1) approve the first reading of ordinance 290 amending the city's subdivision code section 600.35 regarding park dedication requirements <u>as written / as amended</u>; (2) waives the second reading; and (3) directs that the resolution be submitted to the Sun-Sailor for publication.
- 2. I move the city council (1) approve the first reading of ordinance 290 amending the city's subdivision code section 600.35 regarding park dedication requirements <u>as written / as amended</u>; and (2) directs that the ordinance be placed on the August council agenda for a 2nd reading.
- 3. Do nothing (maintain current ordinance) or other motion ???

Greenwood code section 1215 requires 2 readings of all ordinances prior to adoption. The 2nd reading shall be within 3 months of the 1st reading. There may be changes between the 1st and 2nd readings. The 2nd reading may be waived by a unanimous vote of city council members present at the meeting. In order to publish an ordinance by title and summary the ordinance must be approved by a 4/5ths vote. Ordinances go into effect once they are published in the city's official newspaper. The planning commission must review and make a recommendation to the city council regarding any changes to the zoning code chapter 11. A public hearing, typically held by the planning commission, also is required for changes to chapter 11.

ORDINANCE NO. 290

AN ORDINANCE OF THE CITY OF GREENWOOD, MINNESOTA AMENDING GREENWOOD ORDINANCE CODE SECTION 600.35 REGARDING PARK DEDICATION REQUIREMENTS

THE CITY COUNCIL OF THE CITY OF GREENWOOD, MINNESOTA DOES ORDAIN:

SECTION 1.

SECTION 2

Greenwood ordinance code section 600.35, Subd. 3 is amended to read as follows:

"Subd. 3. Park Dedication. Park dedication fees are established to ensure that every new lot bears a proportionate share of the overall park system burden. As such, The council may require 8% of each proposed subdivision to be dedicated for public use as parks, playgrounds, trails, or open space, but not including land necessary and dedicated for stormwater holding areas or ponds. Such dedicated land must be suitable for parks or playgrounds and shall conform to the city plan for parks and playgrounds. As an alternative, the council may require that the subdivider contribute a cash amount equal to 8% of the assessor's land valuation for the entire parcel prior to subdivision on January 2 of the year of the final plat application. If the subdividing property owner can prove that the property was subject to the park dedication requirement (land or cash) prior to subdivision, then the subdivided parcel that contains the principal structure shall be exempt from the park dedication requirement. All other newly created parcels shall be subject to the park dedication requirement. Cash payments will be placed in a special park fund and will be used only for the acquisition and development or improvement of parks, playgrounds, trails, wetlands, or open space."

Effective Date. This ordinance shall be effective upon p	ublication according to law.
