South Lake Minnetonka Police Department Firearms Safety Program

Operation Lock & Unload

Operation Lock & Unload is a South Lake Minnetonka Police Department (SLMPD) initiative that focuses on the safe storage of firearms. Simply hiding a gun without taking additional precautions is not a safe practice. Proper safeguards include unloading the firearm, using a trigger or cable lock, and placing the gun in a lock box or safe. Ammunition should be securely stored away from the firearm. The SLMPD offers free cable locks that will secure most types of guns. To learn more about firearm safety, visit www. projectchildsafe.org.

unsure how to properly dispose of them. The SLMPD offers this simple 3-step, no-hassle process:

- 1. Call SLMPD Dispatch 952.258.5321.
- 2. Specify that you would like a police officer to contact you about the disposal of an unwanted firearm and / or ammunition.
- 3. A police officer will call you back and make a determination on whether to have an officer pick up the item(s) or have you bring the item(s) to the police station.

## **Emerald Ash Borer**

EAB is a destructive pest that attacks all species of ash trees. Since ash trees have NO natural defense to EAB, trees will die in 1-4 years once infested. Eventually all ash trees will die unless successfully treated. Treatment costs approximately \$100 for a 20" diameter tree and must be done 1-3 years in perpetuity. EAB has been located in Plymouth and will spread to Greenwood.

HOW TO IDENTIFY EAB: EAB larva creates S-shaped galleries under the bark. An adult EAB is a slender elongated insect 1/3 to 1/2 inch long, iridescent-green to copper-green in color, and leaves a D-shaped exit hole in the bark. If you suspect you have found EAB, call the hotline at 651.201.6684.

WHAT THE CITY IS DOING: On city property, the city forester will mark ash trees for removal if they are weak specimens located close to a public street / trail / play area or have the potential to interfere with utility lines. Otherwise, ash trees on public property will become habitat for wildlife.

WHAT YOU NEED TO DO: Consult with a certified arborist to determine options for privately-owned ash trees.

HOW YOU CAN HELP: Hennepin County is under a quarantine that prohibits the movement of any hardwood firewood as well as ash branches. Do not transport firewood to campgrounds or parks.

Greenwood Quarterly 1ST QUARTER 2016

Happy New Year! As we begin 2016, I would like to share a few city items of interest ...

- The city council approved the final 2016 city budget that includes a slight -0.05% reduction in the tax levy. I am pleased to report that we have reduced the city's tax levy every year since I have been mayor (7 years).
- Building permit revenue has increased significantly over the last few years (\$11,319 total in 2010 compared to \$67,347 total in 2014, and \$58,875 as of 11/30/15).
- The city council approved ordinance updates regarding municipal watercraft spaces, commercial sign measurements, and accessory structures. The updates have been incorporated into the code book that is available for viewing at www.greenwoodmn.com and at City Hall. City dock slip holders and those on the waiting list will be sent a copy of the new watercraft ordinance.
