COVID-19 & Civil Unrest

To address COVID-19 and civil unrest in the wake of the tragic death of George Floyd, the following emergency declarations were issued ...

- On Mar 20, the mayor issued a Statement & Determination to allow the city to conduct meetings electronically.
- On Apr 1, the council approved the mayor's Mar 31 Declaration of Local Emergency to allow the city to receive reimbursement for costs related to COVID-19.
- On Jun 1, the council extended the mayor's May 30, Declaration of Local Emergency & Nighttime Curfew Proclamation to authorize the mayor to implement curfews recommended by Chief Meehan.

Residents also might be interested to know that our **SOUTH LAKE** MINNETONKA POLICE DEPARTMENT'S **COMMITMENT TO CRISIS INTERVENTION** TRAINING / DE-ESCALATION TRAINING

preceded the Peace Officers Standards & Training Board mandates by a couple of years. Every SLMPD officer (including supervisors and investigators) who routinely engages in 911 response is sent to the 40-hour CIT course, which is considered the gold standard for CIT/ de-escalation training. It includes live training scenarios where officers must demonstrate their learned abilities using specially trained role-players. In addition to the initial training, officers are sent to an 8-hour refresher during every licensing cycle.

The SLMPD also meets and, in most cases, exceeds the training requirements in CONFLICT MEDIATION AND IMPLICIT **BIAS.** This training provides officers with additional tools that help them to be better communicators.

The SLMPD's USE-OF-FORCE POLICY DOES NOT INCLUDE CHOKE-HOLDS and officers do not train in the application of choke-holds.

CITY COUNCIL EXPLORING **OPTIONS FOR ALL CITY SERVICES**

Currently, Greenwood contracts for most services through the city of Deephaven. They provide meeting space, administrative services, bookkeeping, utility billing, planning and zoning, public works, and more. In April, Deephaven notified Greenwood that they are not going to provide public works and planning and zoning services for Greenwood beginning 01.01.21. The Greenwood city council has decided that this is a good impetus to explore options for all city services.

Engineering Projects

This year's <u>proposed</u> projects include the **MINNETONKA BLVD TRAIL** improvements between St. Alban's Bay Road and West Street to improve drainage and safety; survey of **SHUMAN WOODS**; striping on MEADVILLE ST; and MISC. PATCHING. We will work with Shorewood to determine timing for projects on MINNETONKA **BLVD** (south of Ferncroft to the Deephaven border) and on ST. ALBAN'S BAY RD (between Mtka Blvd and Manor Rd). Reconstruction of LINWOOD CIRCLE will be done in conjunction with Mtka Blvd. The council will determine final projects at the 07.07.20 meeting.

2020 Election

In addition to federal, state, and regional offices, this year's election includes voting for the mayor and 2 city council seats currently held by

Councilmembers Kristi Conrad and Bill Cook. All terms are 4 years. Mayor Deb Kind and Councilman Bill Cook have announced that they are running for re-election.

Zebra Mussels Research in St. Alban's Bay

Once again, the USGS and Minnesota Aquatic Invasive Species Research Center are working on a joint project in St. Alban's Bay. No chemical treatments will be applied this year. The goal is to assess the prior treatment's residual impacts on the zebra mussel population and other aquatics. BUOYS WITH LIGHTS HAVE **BEEN DEPLOYED IN 12-15FT OF WATER IN NAVIGATION AREAS** and identify where cages with test organisms are submerged.
