Board of Appeals Scheduled for Thursday, April 16

By now, Greenwood residents have received their property valuation notices. However, if you question the valuation, you have the opportunity to state your case at the Local Board of Appeals meeting. To get on the agenda for this meeting you need to do a couple things. First, you must call Greenwood's City Assessor. Often, the Assessor will meet you at your property and discuss how the value was determined. If you still want to proceed with your appeal, you then must REGISTER with the City Administrator by Thursday, April 9, 2009, and your name will be placed on the Board of Appeals agenda. If you can't appear in person, you may send a representative or forward your documentation to City Hall by Thursday, April 9.

The Board of Appeals will meet on Thursday, April 16, 2009, at 6:30 p.m. in the Greenwood City Council Chambers in Deephaven.

Remember, you must first talk to the City Assessor before you can meet with the Board of Appeals.

Emergency Preparedness

The City of Greenwood is part of the Lake Minnetonka Regional Emergency Preparedness Plan. The South Lake Minnetonka Police Department (SLMPD) has primary responsibility for coordinating and implementing this plan for Greenwood as well as the cities of Excelsior, Shorewood, and Tonka Bay. This is done in partnership with the Excelsior Fire District (EFD), which serves these same four communities along with the City of Deephaven. The Emergency Operation Center for these communities is located at the South Lake Minnetonka Public Safety Facility in Shorewood. This state-of-the-art facility also serves as headquarters for both the SLMPD and EFD. Saturday, May 2, is Spring Clean-up Day

Greenwood's recycling contractor, Vintage Waste, will begin making the loop from Minnetonka Blvd & Byron Circle at 7:00 a.m. on Saturday, May 2. They will end by 2:00 p.m. at Excelsior Blvd. & MacLynn Road. Items for pick-up must be on the curb before 7:00 a.m. A second trip will NOT be made through the City. Please take advantage of this easy opportunity to get rid of your unwanted items. ACCEPTED ITEMS:

Yard waste: grass and leaves must be bagged and weigh under 50 pounds per bag. Branches must be bundled with twine and no longer than 5' in length. You may use garbage cans for loose sticks if the filled can weighs under 50 pounds.

Misc: couches, beds, chairs, desks, cabinets, tables, box springs, mattresses. Carpet is accepted if it is rolled and tied in 5' sections (no nails). Lawn mowers, snow blowers and weed whips must be drained of gas and oil or they will be left behind. Small debris (no nails) is allowed as long as it is in a sturdy box and under 50 pounds. Construction debris must be boxed. No loose piles of wood or sheetrock will be picked up.

Grills, bikes, swing sets, water softeners, air conditioners and dehumidifiers will be accepted but must be broken down into 5' lengths or less.

ITEMS NOT ACCEPTED:

Concrete, propane tanks, large appliances, electronics (TV's, computers, radios), fluorescent bulbs, gas, tires, car batteries, paint, oil, grease, aerosol paint cans, fertilizer or herbicide. Hazardous waste will be left behind.
